第52(1)條 / Section 52(1)

在某人就指明住宅物業與擁有人訂立臨時買賣合約時，該人須向擁有人支付售價的5%的臨時訂金。

A preliminary deposit of 5% of the purchase price is payable by a person to the owner on entering into a preliminary agreement for sale and purchase in respect of the specified residential property with the owner.

第53(2)條 / Section 53(2)

After the Vendor has received the application and duly verified the information to be correct, the Vendor will pay the Early Settlement Cash Rebate to the Purchaser by issuing a cheque drawn in the Purchaser's favour within 45 working days after the date of full settlement of the Purchase Price.
