The areas of other specified items (if any), to the extent that they form part of the residential property (not included in saleable area) are calculated in accordance with Part 2 of Schedule 2 to the Residential Properties (First-hand Sales) Ordinance.

### Notes

- 1. The areas as specified above in square feet are converted from the areas in square metres at a rate of 1 square metre=10.764 square feet and rounded off to the nearest integer, which may be slightly different from the areas presented in square metres.
- 2. There is no verandah in the residential properties in the Phase.
- 3. Residential floors start from 5/F. There are no 13/F, 14/F, 24/F and 34/F in each Tower.

每個住宅物業的實用面積,以及構成住宅物業的一部分的範圍內的露台、工作平台及陽台(如有)的樓面面積是按照《一手住宅物業銷售條例》第8條計算得出的。

構成住宅物業的一部分的範圍內的其他指明項目(如有)的面積(不計算入實用面積),是按照《一手住宅物業銷售條例》附表2第2部計算得出的。

### 附註:

- 1. 上述以平方呎表述之面積以1平方米=10.764平方呎換算,並以四捨五入至最接近整數平方呎之方法計算得出,與以平方米表述之面積可能有些微差異。
- 2. 期數住宅物業並無陽台。
- 3. 住宅樓層由5樓開始。每座不設13樓、14樓、24樓及34樓。
