Purchasers will have to pay monthly instalments and interest will be accrued starting from the day of drawdown within 100 days after signing of the Preliminary Agreement for Sale and Purchase and interest on mortgage loan will be calculated at 1.75% below the Hong Kong Dollar Best Lending Rate (P-1.75%p.a.) as quoted by The Hongkong and Shanghai Banking Corporation Limited ("the Best Lending Rate") from time to time for the first 36 months and at 0.75% below the Best Lending Rate (P-0.75%p.a.) within the period from the 37th month to the 60th month; and thereafter will be calculated at 1.25% above the Best Lending Rate (P+1.25%p.a.), subject to fluctuation.
